



### Invitation for Bids

- The Kanchanrup Municipality, Saptari has allocated funds towards the cost of Physical Infrastructure projects and intends to apply part of the funds to cover eligible payments under the Contract as listed below in the table.
- Bidding will be conducted through National Competitive Bidding (NCB) procedures (Model Bidding Document as per Electronic Government Procurement issued by PPMO). This is open to all eligible bidders.
- Eligible Bidders may obtain further information and inspect the Bidding Document at the Kanchanrup Municipality, Kanchanpur, Saptari, Phone No. : 031-560114, e-mail id: kanchanrupmunicipality@gmail.com. and inspect the Bidding Documents at the address given below during office hours or may visit e-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np/eGP>
- A complete set of bidding documents in English may be purchased by the interested bidders upon submission of a written application to the Kanchanrup Municipality, Kanchanpur, Saptari and upon payment of a non-refundable fee as shown in the table given below. Bidding documents can be purchased during office hours till 2075-02-17(31 May 2018) from Kanchanrup Municipality, Kanchanpur, Saptari. If so requested, the Bidding Documents can also be sent by post/courier services within Nepal upon payment of additional cost of NRS. 500. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
- For the purpose of Bidders who choose to submit their bid electronically through e-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np/eGP>, the Bidders may either purchase the hard copy of bidding documents or may choose to download the bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the bidder shall be required to deposit the cost of bidding document (as specified in the table below) in the Employer's Sanchit Kosh account as specified below and scanned copy (PDF format) of the Bank deposit voucher shall also be submitted along with the electronic submission of the bid files. - Pre-bid meeting will be held at Kanchanrup Municipality, Saptari at 12.00hrs on 2075-02-04(18 May, 2018).
- Sealed or electronic bids must be submitted to the Kanchanrup Municipality, Saptari by hand/courier or through PPMO website [www.bolpatra.gov.np/eGP](http://www.bolpatra.gov.np/eGP) on or before 12:00 hrs of 2075-02-18(1 June 2018). Late bids will be rejected and not opened. The bids will be opened physically and electronically at 13:00 hours on 2075-02-18(1 June, 2018) in the presence of the bidders' representatives who choose to attend at Kanchanrup Municipality, Saptari.
- All bids shall be accompanied by a Bid Security for the amount as specified in the table below in local currency. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security guarantee shall conform to the standard format as specified in the bid document. The bid security guarantee issued only by the "A" class commercial bank approved by Nepal Rastra Bank shall be accepted by the Employer.
- Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid. in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non responsive.
- Bids shall be valid for the period as mentioned in the table below after the deadline for Bid submission and Bid security shall be valid up to the period as mentioned in the table above.
- The Kanchanrup Municipality, Saptari reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
- If the last date of pre-bid meeting, purchasing and /or submission falls on a government holiday, then the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- The bidder may bid for any or all of the slices/packages as invited in the IFB. Bidders, bidding for more than one slice/package will so indicate in their bid, together with a statement regarding any discount / cross discounts offered, but the Employer may approve the bid for one or any least cost combination of contracts subject to bidders meeting the qualification. The bidder should meet the qualification criteria separately for each Bid and in aggregate as stated in the Instruction to Bidders.
- Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
